Investigation Narrative

ON 03-21-16 AT 1810 HRS I RECEIVED A CALL FROM DISPATCH WHO STATED THERE WAS A SUBJECT IN THE LOBBY WHO WANTED TO CONFESS TO HAVING SOMEONE KILLED. I MADE CONTACT WITH MR. DAVIDSON AND HIS WIFE MS. DAVIDSON AND HAD DET YARBROUGH ESCORT THEM TO AN INTERVIEW ROOM.

MYSELF AND DET YARBROUGH SAT DOWN WITH MR. DAVIDSON TO TALK ABOUT WHAT HE WAS ATTEMPTING TO CONFESS TO. DET YARBROUGH ADVISED HIM OF HIS RIGHTS WHICH HE WAIVED AND AGREED TO SPEAK TO US.

HE BEGAN BY TELLING US THAT HE BEGAN AN INTERNET AFFAIR WITH A FEMALE BY THE NAME OF JACQUELINE ENRIQUE. HE STATED THAT IT WAS THE GIRLFRIEND OF HIS ADOPTED SON JOHNNY. HE SAID THAT THE INTERNET AFFAIR ONLY LASTED A FEW WEEKS AND HE FINALLY TOLD HIS WIFE ABOUT IT. HE TOLD ME THAT DURING THIS TIME JACQUELINE WAS PREGNANT WITH TWINS. HE STATED THAT SHE HAD THE TWINS IN SEPTEMBER. HE STATED THAT ONCE HE BROKE IT OFF SHE CONTINUED TO CONTACT HIM AND WANTED TO KEEP THE AFFAIR GOING. HE WAS ASKED IF SHE WAS ATTEMPTING TO BLACKMAIL HIM FOR MONEY AND HE STATED NO. HE STATED THAT DURING THIS TIME WHEN THE TWINS WERE BORN THAT SHE WAS AN ABUSIVE PARENT AND HAD INJURED THE CHILDREN AND ONE HAD GONE TO HAMILTON MEDICAL CENTER. HE TOLD US THAT SHE WAS LIVING IN A CONDO ON MOUNT HAVEN DR. HE STATED THAT BECAUSE OF ALL OF THE THINGS SHE WAS DOING THAT HE WAS APPROACHED BY TWO FRIENDS WHO STATED THEY WOULD TAKE CARE OF HER FOR HIM. HE TOLD THEM OK AND THEY AGREED. HE MADE CONTACT WITH THEM AFTER THEY RETURNED AND HE STATED THEY TOLD HIM THAT THEY HAD TAKEN CARE OF HER AND HE ASKED IF THEY SCARED HER AND THEY SAID WORSE THEN THAT. HE SAID HE TOOK IT AS THEY HAD KILLED HER.

MR. DAVIDSON WOULD NOT TELL US WHO THE TWO FRIENDS WERE OR HOW TO GET IN TOUCH WITH THEM. WE CHECKED SEVERAL SYSTEMS AND WERE NOT ABLE TO VERIFY THAT THIS JACQUELINE EVEN EXISTED. HE WAS EXTREMELY VAGUE IN HIS RESPONSES TO INFORMATION THAT WOULD ASSIST US OR HE WOULD SAY THAT HE HAD DELETED THE INFORMATION. MR. DAVIDSON DID STATE THAT HE WAS ON SEVERAL DIFFERENT MEDICATIONS FOR DEPRESSION AND HAD ONLY JUST GOTTEN OUT OF THE HOSPITAL TODAY. WE WERE NOT ABLE TO LOCATE ANY REPORTS OR MISSING PERSONS THROUGH OUR SYSTEM OR GCIC. WE EVEN CONTACTED FLOYD COUNTY TO SEE IF THEY HAD ANYTHING SIMILAR IN NAME REPORTED MISSING. WE WERE NOT ABLE TO VERIFY ANY INFORMATION THAT HE PROVIDED TO BE ACCURATE. IT APPEARS THE SUBJECT MAY BE DELUSIONAL OR HAVE SOMETHING ELSE THAT HAD OCCURRED THAT IS CAUSING HIM TO HAVE THESE THOUGHTS. THERE WILL BE SOME ADDITIONAL FOLLOW UP TO TRY AND CONTACT A SUBJECT WHO HE CALLS JOHNNY HIS ADOPTED SON WHO HE STARTED HELPING OUT.

THERE IS NO WAY TO VERIFY ANY OF THE INFORMATION PROVIDED TO BE TRUE AND IT DOES NOT APPEAR AT THIS TIME ANYTHING HE SAID IS ACCURATE. MR. DAVIDSON WAS TRANSPORTED TO THE HAMILTON MEDICAL CENTER AFTER OUR INTERVIEW BASED ON HIM THINKING ABOUT HURTING HIMSELF. THERE IS NOTHING FURTHER AT THIS TIME.
