Narrative

ON 012517 WHILE AT DALTON HIGH SCHOOL I (OFFICER CHANDLER) WAS INFORMED A STAFF MEMBER MIGHT BE MISSING.

I WAS ADVISED MR. DAVIDSON HAD SPOKEN WITH HIS SUPERVISOR AT APPROXIMATELY 1500 HRS IN REFERENCE TO HIM NOT FEELING WELL. MR. DAVIDSON STATED HE WAS GOING TO LEAVE FOR THE REMAINDER OF THE DAY.

AT APPROXIMATELY 1600 HRS JOHNNY DAVIDSON (MR. DAVIDSON'S SON) ARRIVED AT THE SCHOOL TO PICK HIM UP BECAUSE DAVIDSON DID NOT DRIVE TO WORK TODAY. JOHNNY ADVISED DAVIDSON HAD SENT HE AND HIS MOTHER A TEXT AT APPROXIMATELY 1440HRS THIS DATE ASKING FOR SOMEONE TO COME PICK HIM UP DUE TO NOT FEELING WELL.

MR. DAVIDSON COULD NOT BE LOCATED INSIDE THE SCHOOL BUT WAS SEEN BEFORE THE END OF THE SCHOOL DAY IN THE FAR EAST HALLWAY OF THE SCHOOL BY OTHER STAFF MEMBERS. THIS LOCATION WOULD BE UNUSUAL FOR DAVIDSON TO BE IN DUE TO HIS CLASS AND DEPARTMENT BEING LOCATED ON THE OTHER END OF THE SCHOOL.

AT THIS TIME STAFF MEMBERS AND I BEGAN SEARCHING INSIDE THE SCHOOL IN AN ATTEMPT TO LOCATE DAVIDSON.

DUE TO MR. DAVIDSON HAVING A HISTORY OF MEDICAL PROBLEMS I CONTACTED HAMILTON MEDICAL CENTER, AND CID.

WHEN I SPOKE WITH CID I WAS ADVISED MR. DAVIDSON WAS SEEN WALKING EAST BOUND ON WAUGH ST NEAR THE INTERSECTION OF TRAMMEL ST AT APPROXIMATELY 1520HRS. I THEN ADVISED OTHER OFFICERS AND STAFF MEMBERS OF HIS LAST KNOWN LOCATION.

AT APPROXIMATELY 1700 HRS I WAS CONTACTED VIA SCHOOL RADIO BY SCHOOL STAFF AND ADVISED DAVIDSON WAS LOCATED ON SCHOOL ST NEAR THE INTERSECTION OF APRIL ST.

I CONTACTED EMS AND RESPONDED TO THIS LOCATION.

WHEN I ARRIVED ON SCENE I OBSERVED DAVIDSON SITTING ON THE CURB BEING HELD UP BY TWO SCHOOL STAFF MEMBERS.

DAVIDSON WAS CONSCIOUS AND DID NOT APPEAR TO BE IN ANY TYPE OF PHYSICAL DISTRESS. I ATTEMPTED TO SPEAK WITH DAVIDSON AS DID STAFF MEMBERS BUT NO AMOUNT OF STIMULUS WOULD DRAW A RESPONSE FROM DAVIDSON.

EMS ARRIVED AND TRANSPORTED DAVIDSON TO HAMILTON MEDICAL CENTER.

JOHNNY DAVIDSON WAS ADVISED TO RESPOND TO HAMILTON MEDICAL CENTER.

NO FURTHER ACTION WAS TAKEN AT THIS TIME.
