In any case, I presume that we are all aware that several freshmen are said to have been hazed in Gatlinburg with a pool cue?

Therein is my question – setting aside the rape victim, what have we done to reach out to the other students/victims? To my knowledge, none of them have retained attorneys, so school officials are free to be as compassionate toward them as they ought to be. If we have done nothing, then let's do something. If you are not sure what the appropriate limits might be under these circumstances, then formulate a plan and run it by me. Don't let me drive or limit the plan; start with what you think is appropriate and then let me reign you in but ONLY if I think it is necessary.

As for the other students who were on the team, so I understand that you have something in common – everyone is uncertain about the status of the team. You do not need to know what the future holds in order to contact them and see how they are doing, nor do you need my permission.

They have said that they feel forgotten in the mess over the central office. I told Ms. Bullard that, I think, HCDE did offer counselling to the known victim. And I also think that counselling was offered to everyone at the school. Am I wrong? Regardless, please, someone, reach out to each of the victims, ask how they are doing, and offer counselling. If they have incurred counselling costs out of pocket, offer to pay for it.

The players' parents complain that the season was cancelled and no one has communicated with them, neither before nor since. Some of the players apparently transferred to other schools, and no one has called to check on them. I can see how they would fall through the cracks, but perhaps someone – guidance or an AP? – ought to call and check on them.
