It having come to the attention of the Court that HOPE BONDING BRADLEY has executed bonds over the authorized limit, and has outstanding conditional forfeitures.


NOW, THEREFORE,

1. HOPE BONDING BRADLEY shall be placed in a suspended status and prohibited from making any new bonds until such time as additional funds are placed on deposit with the Clerk of Courts or outstanding bonds are satisfied.
2. HOPE BONDING BRADLEY shall be suspended from the approved list of bonding companies in and for the Tenth Judicial District, State of Tennessee.
3. HOPE BONDING BRADLEY shall remain suspended unless and until it is reinstated by Court order.
4. HOPE BONDING BRADLEY may request a hearing on this suspension and show cause why they should otherwise be entitled to immediate reinstatement.
5. The clerk of Courts with whom this order is filed is ordered to notify Hope Bonding Bradley of this status. The clerk is further directed to notify all of the Clerks of Court, the Criminal and General Sessions Court Judges, the District Attorney's Offices, and the County Sheriff's Offices in the Tenth Judicial District.


