On Sunday June 10, 2018, Donna Kirby went to Lake Winnepesaukah with her mother, Lazelle Moore, her daughter Kaitlyn Kirby, age 17 and her daughter's boyfriend Nhan Le, age 17. They arrived at approximately noon. They had lunch and then rode the Pirate Ship and Tilt a Whirl with no problems.

Ms. Kirby's daughter and her boyfriend went to the water park area. Ms. Kirby and her mother went to the coaster area of the park. They decided to ride Wild Lightnin', which neither had ever ridden before.

There was almost no line and they walked up to the front loading area.

There was a young female ride attendant wearing a Lake Winnepesaukah shirt.

Ms. Kirby told the attendant she (Ms. Kirby) had some knee issues making it difficult to fully bend them. Ms. Kirby requested to get into the ride car and be sure it would be safe to ride. Ms. Kirby sat in the front seat of the car with her backside on the left side of the seat area and her legs angled to the right and forward. She pulled down and locked the lap bar and asked the first attendant if it looked safe with her legs angled. The first ride attendant called over another female attendant and both looked and agreed it was safe to continue.

The Lap bar was pulled down against Ms. Kirby's legs and was touching and over her leg area.

Ms. Kirby was holding hand rails with both hands.

Ms. Kirby's mother was seated in the same car, but in the seat behind her.

The ride was rougher than she expected and she was holding to brace herself. After the first few turns; and at a height estimated to be about two stories from the ground, her legs slipped out from the lap bar, her body shot to the left and up, and she fell out of the car. She believes it was during a hard right turn.

Ms. Kirby struck something on the way down and then landed on the ground.

She was obviously stunned, disoriented and in great pain. She recalls park personnel coming to the area. An ambulance was called and she was taken to Erlanger Medical Center.

Ms. Kirby suffered a fractured shoulder and upper arm, which has required surgery. She also has a broken clavicle and severe soreness and bruising all over her body. At this point there may be other injuries which have not been fully discovered.
