#### ORDER

It is further Ordered that service of a copy of this Order to Show Cause and the Verified Petition for Abatement of Nuisance annexed thereto shall be served upon the said Respondents.

## VERIFIED PETITION FOR ABATEMENT OF NUISANCE

Comes now Petitioner, State of Tennessee *ex rel*. Phillip A. Noblett, City Attorney for the City of Chattanooga, and brings this Verified Petition for Abatement of Nuisance, and for its cause of action would state the following:

#### **PARTIES**

- 1. Petitioner is the State of Tennessee ex rel. Phillip A. Noblett, City Attorney for the City of Chattanooga. The City of Chattanooga (hereinafter referred to as "City") is a municipal corporation organized and existing under the laws of the State of Tennessee. The City and its officers are charged with enforcement of laws regarding the health, safety, and welfare of the public and the conduct of persons within the corporate boundaries of the City.
- 2. Respondent, Bankable Holdings LLC d/b/a Coyote Jacks Saloon, formerly d/b/a Bella Vita Restaurant, is a limited liability company with its principal place of business in Hamilton County, Tennessee. Bankable Holdings LLC may be served by serving its Registered Agent, Tammie R. Taylor, at 1400 Cowart Street, Chattanooga, Tennessee 37408.



- 3. Respondents, Tammie Renee Taylor (hereinafter "Taylor") and Ronald J. Berke (hereinafter "Berke), are residents of Hamilton County, Tennessee. Taylor and Berke are members and principal operators of Bankable Holdings LLC d/b/a Coyote Jacks Saloon formerly d/b/a Bella Vita Restaurant. In addition, Taylor is the registered agent of Bankable Holdings, LLC. Taylor and Berke may be served at their residence located at 214 N. Crest Road, Chattanooga, Tennessee 37404.
- 4. Respondent, Cow Art LLC, is the record owner of certain real property located at 1400 Cowart Street, Chattanooga, Hamilton County, Tennessee, and more particularly described in Exhibit A attached to this Petition. The property described in Exhibit A will be referred to here as the "Subject Premises." Cow Art LLC may be served by serving its Registered Agent, Evans Harrison Hackett PLLC, Philip Byrum, Esq., 835 Georgia Avenue, Suite 800, Chattanooga, Tennessee 37402

## CAUSES OF ACTION

- 5. This cause of action is commenced pursuant to Tennessee Code Annotated § 29-3-101 et. seq., which provides for the abatement of any nuisance. Tennessee Code Annotated § 29-3-101, in relevant part, sets forth the following types of nuisance activity which may be abated by court action:
  - (2) "Nuisance" means that which is declared to be a nuisance by other statutes, and, in addition, means:
    - (A) Any place in or upon which lewdness, prostitution, promotion of prostitution, patronizing prostitution, unlawful sale of intoxicating liquors, unlawful sale of any regulated legend drug, narcotic or other controlled substance, unlawful gambling, any sale, exhibition or possession of any material determined to be obscene or pornographic with intent to exhibit, sell, deliver or distribute matter or materials in violation of §§ 39-17-901--39-17-908, § 39-17-911, § 39-17-914, § 39-17-918, or §§ 39-17-1003--39-17-1005, quarreling, drunkenness, fighting, breaches of the peace are carried on or permitted, and personal property, contents, furniture,

fixtures, equipment and stock used in or in connection with the conducting and maintaining any such place for any such purposes;

\* \* \*

- (3) "Person" means and includes any individual, corporation, association, partnership, trustee, lessee, agent or assignee; and
- (4) "Place" means and includes any building, room enclosure or vehicle, or separate part or portion thereof or the ground itself and all the property on which the nuisance is located that is under the ownership, management or control of the violator.
- (b) Any person who uses, occupies, establishes or conducts a nuisance, or aids or abets therein, and the owner, agent or lessee of any interest in any such nuisance, together with the persons employed in or in control of any such nuisance by any such owner, agent or lessee, is guilty of maintaining a nuisance and such nuisance shall be abated as provided hereinafter.
- 6. The Court has jurisdiction over this matter as provided in Tennessee Code Annotated § 29-3-102, which extends jurisdiction to "chancery, circuit, and criminal courts and any court designated as an environmental court pursuant to Chapter 426 of the Public Acts of 1991...."
- 7. Hamilton County, Tennessee is the proper venue for this action. The relevant statute provides "[w]hen a public nuisance, as defined in Tennessee Code Annotated § 29-3-101, is kept, maintained, carried on, or exists in any county, a bill or petition may be filed in any chancery, circuit, or criminal court of such county..." Tenn. Code Ann. § 29-3-103.
- 8. The nuisance activity is connected with the business operations of a parcel of real property with its appurtenances and attachments, located at 1400 Cowart Street, Chattanooga, Tennessee 37408, and operated as a business known as Coyote Jacks Saloon. Coyote Jacks Saloon is operated by Bankable Holdings, LLC, and the real property is owned by Cow Art LLC.
- 9. This Complaint follows an investigation by the Chattanooga Police Department and the Chattanooga Office of the City Attorney. This investigation revealed, *inter alia*, as follows:

- (a) Bankable Holdings LLC d/b/a Coyote Jacks Saloon, formerly d/b/a Bella Vita Restaurant, is the site of a disproportionate amount of illegal activity. Between January 1, 2015 and October 6, 2019, officers from the Chattanooga Police Department have responded to the business for approximately 470 calls for service, with over 250 of those calls involving crimes that include narcotic violations, assaults (aggravated and simple), complaints of shooting weapons, thefts, robberies, attempted rape, property damage, assault on officers, weapons law violations, and other criminal offenses. *See* attached Chattanooga Police Department Crime Analysis Unit Summary (Exhibit B). At least Fifteen (15) of those calls involved weapons violations, shots fired/person shot/stabbings. *See* attached Call Summary with Narratives (Exhibit C).
- (b) For example, the following activity has occurred at or near 1400 Cowart Street within the past three years:
  - 1. On May 8, 2016, at approximately 2:12 a.m. Chattanooga police received a call about a disorder at Bella Vita. Police Officers proceeded into the parking lot across from the club and as they were driving through the parking lot towards the club heard what sounded like one gun shot and then noticed several people running from the club. The Officers exited their vehicles and went to the club. As they approached W. 14th Street, they encountered several security guards who were holding a party they said did the shooting. Another security guard pointed to a shirt in the street which he said was covering the gun used in the shooting. An Officer secured the gun in his car. When another Officer reached the front of the club he encountered 2 more security guards, one was attending to a party who was shot and the other was detaining a party on the ground. The detained person was arrested. HCEMS 9 arrived and transported the victim to Erlanger. While looking for the victim's identification the Officer found a gun in the victim's left front pocket. Officers who responded to Erlanger advised that the victim had been pronounced dead.
  - 2. On December 17, 2017 at 02:50 a.m. a Chattanooga Police Officer responded to a complaint of possible shots fired. While en route, dispatch alerted police that multiple calls had come in that a person had been shot in front of Coyote Jacks Saloon nightclub. Upon arrival Police found two victims shot in the parking lot of Coyote Jacks Saloon nightclub. One of the victims was unconscious and appeared to have a wound to the chest. The other victim appeared to have a wound to the leg. Witnesses told Police a verbal argument had occurred between the suspects and the victims inside the night club and they decided to go outside and fight in the parking lot. Witnesses stated that when they went to the parking lot someone started

- shooting and suspects fled. The victims were transported by Medics 13 and 14 to Erlanger Hospital. One victim later died from the wounds received.
- 3. On July 15, 2018 at 2:55 a.m. police received a call of shots fired at 1400 Cowart St. Coyote Jacks Saloon. Dispatch advised 50 shots and multiple calls from the same location. Upon arrival police observed 100 or more people fleeing the scene. Police heard several parties screaming and yelling about someone being shot. Police located the first two victims, and they were transported by medic 13 Erlanger Hospital. Police then located a third victim who was transported by medic 9 to Erlanger Hospital. 9-1-1 dispatch then advised that two other victims were transported via personal vehicle suffering from gunshot wounds.
- 4. On October 6, 2019, the Chattanooga Police Department made a bar check and discovered severe and dangerous overcrowding of the part of the premises in use. During the time patrons of the Coyote Jacks Saloon were dispersing, a crowd gathered on the Coyote Jacks outside patio and a fight broke out. During the fight, shots were fired striking and killing an individual.
- 10. Petitioner prays that the Court should temporarily and permanently enjoin the Respondents' use of the Subject Premises to create a public nuisance for the public, in particular business occupants and residents in or near 1400 Cowart Street, in violation Tennessee Code Annotated § 29-3-101(2) and other applicable laws as contemplated by Tennessee Code Annotated § 29-3-110. Any injunctive remedy should be provided in accordance with Tennessee Code Annotated §§ 29-3-106 and 29-3-110 and other Tennessee state laws.
- 11. Petitioner prays that Respondents should be temporarily enjoined from using the subject premises pursuant to Tennessee Code Annotated § 29-3-106 within five (5) days' notice to the Respondents and this injunctive relief should be made into a permanent injunction in accordance with Tennessee Code Annotated §§ 29-3-110.

WHEREFORE, Petitioner demands judgment against Respondents, as follows:

1. That the Court issue process in this matter and order Respondents, and Respondents' agents and employees, to appear and show cause why they should not be temporarily and permanently restrained from allowing breaches of the peace involving shootings, quarreling,

drunkenness, fighting, and other breaches of the peace, from occurring on any occasion on the Subject Property in violation of the laws of the State of Tennessee.

- 2. That the Court set a hearing in this case to be heard on October 227, 201 at 10:00 A.m. and issue a Show Cause Order to Respondents requiring them to appear and Show Cause why a Temporary Restraining Order as contemplated by T.C.A. § 29-3-106 should not be issued.
- 3. That the Court hold a trial on this matter pursuant to Tennessee Code Annotated § 29-3-108 and enter a permanent injunction at that time pursuant to Tennessee Code Annotated §§ 29-3-110.
- 4. That the Court grant such other and further general relief including permanent injunctive relief as it deems to be just and equitable.
  - 5. That Petitioner will suffer irreparable harm if injunctive relief is not granted.
- 6. That an injunction bond is not required as contemplated by Tennessee Code Annotated § 29-3-104.
- 7. That a permanent injunction be issued to enjoin Respondents from using their premises or allowing any future incidents of violence, quarreling, drunkenness, fighting and breaches of the peace on its property.
  - 8. For Petitioner's costs of this action; and
  - 9. For such other and further relief that the Court deems just and proper.

## THIS IS THE FIRST APPLICATION FOR EXTRAORDINARY RELIEF.



There have been 470 Calls to Hamilton County 911 for Police Service to 1400 Cowart between January 1, 2015 and October 8, 2019. Not all calls resulted in actual incident reports but the calls to 1400 Cowart exceed by more than double calls for service to other comparable establishments and the calls for Violent Incident Response is more than four times higher than other comparable clubs.
